1. Government of Nepal (GoN) has allocated fund toward the cost of Consultancy Service for Design Review, Construction Supervision, Quality Control & Contract Management for Construction of Headworks, Surge Shaft, Penstock and Powerhouse and intend to apply portion of this fund to eligible payments under the Contract for which this Expression of Interest is invited for International consulting service
2. The Bheri Babai Diversion Multipurpose Project, Department of Water Resources and Irrigation, Nepal now invites Expression of Interest (EOI) from eligible consulting firms (“consultant”) to provide the following consulting services: Consultancy Service for Construction of Civil (Headworks, Surge Shaft, Penstock and Powerhouse) Contract, Hydro-Mechanical Contract and Electro-Mechanical Contract.

4. Consultants may associate with other consultants to enhance their qualifications. However, the Consultant (individual members of any Joint Venture or Association (Sub Consultant)) shall submit only one EOI either in its own name or as part of a Joint Venture or Association (Sub-Consultant).
5. Expressions of interest shall be delivered online through e-GP system www.bolpatra.gov.np/egp on or before 24 February, 2019, 12:00 Noon; and shall be opened in the presence of Consultants’ representatives who choose to attend at 13:00 hrs on the same day at Bheri Babai Diversion Multipurpose Project, Department of Water Resources and Irrigation, Jawalakhel, Lalitpur, Nepal
6. In case the last date of obtaining and submission of the EOI documents happens to be a holiday, the next working day will be deemed as the due date but the time will be the same as stipulated.
7. EOI will be assessed based on Qualification 30%, Experience 60%, and Capacity 10% of consulting firm and key personnel. Based on evaluation of EOI, only shortlisted firms will be invited to submit technical and financial proposal through a request for proposal.
8. Minimum score to pass the EOI is 60 %.
